



## Cornhole Tournament *Vendor Agreement*

The Junior League of Arlington, Inc. (“JLA”), whose mailing address is P.O. Box 13116, Arlington, Texas 76094-0116, will present its Guinness World Record Cornhole Tournament & Family Fun Day (“Cornhole Tournament”) at the UT Arlington Maverick Stadium (“Maverick Stadium”), located at 1307 W. Mitchell St., Arlington, Texas 76013, October 23, 2016 (the “Event Date”).

### **Vendor Booth Rental:**

\_\_\_\_\_ (“Vendor”) whose mailing address is \_\_\_\_\_ agrees to this Vendor Agreement (“Agreement”) from JLA on the Event Date for a 10’ x 10’ booth at Maverick Stadium for \$100.

Vendor tenders herewith a non-refundable booth deposit of \$50. The **deposit** will be applied to the booth rental total and is due with this Agreement **on or before October 7, 2016. Balance of the full booth rental is due on or before October 14, 2016 at 5 p.m.** If the balance of the booth rental is not paid on or before October 14 at 5 p.m., JLA, at its option, may terminate this Agreement and retain the deposit as its liquidated damages. Any deposits or booth rental fees must be paid by check, money order or credit card (through the Fall Fundraiser Treasurer). There will be no refunds for additional fees paid to JLA after October 14.

### **Vendor Hours of Operation:**

The Vendor agrees to move in and arrange merchandise between the hours of 11 a.m. and 1 p.m. Sunday, October 23. The event will run until 5 p.m., and vendors must remove all merchandise and fixtures by 6 p.m.

### **Vendor Badges and Parking:**

Each booth will be provided only 2 merchant badges for the event date.

Each Vendor will be responsible for paying for parking – \$10 per car.

### **Vendor Services:**

Junior League of Arlington will define the booth's space. Vendors will provide, at its own expense, tables and chairs and all other display, lighting or sales fixtures.

### **Vendor Requirements:**

The Vendor will procure, at its sole expense, any permits or licenses including, but not limited to Texas Limited Sales Tax Permit and all other licenses required for the transaction of business at Maverick Stadium and otherwise comply with all applicable laws, ordinances, and governmental regulations. ***Vendor agrees to provide a copy of his Texas Sales Tax Permit for JLA records.***

Vendor assumes all risks of loss arising from any cause whatsoever, as it relates to their merchandise. The Vendor further agrees to indemnify and hold the JLA harmless for any and all claims, causes or action or cost, which result from the negligence, unlawful or willful conduct on the part of the Vendor, regardless of whether such loss, as incurred by the JLA is covered by insurance. Proof of insurance listing the Junior League of Arlington as an additional insured or a signed copy of the Vendor Liability Waiver and Indemnity Contract is required by the Vendor for JLA records.

Junior League of Arlington agrees to list the Vendor as a participant of the Cornhole Tournament where all merchant names are included such as ads, marketing materials and signage. JLA will make no warranties or endorsements nor will it permit to be made any warranties or endorsements on its behalf with respect to the merchandise of the Vendor or any amounts sold or not sold by the Vendor. The Vendor will have sole responsibility for the collection of unpaid accounts, returned checks or returned merchandise.

### **Vendor Social Media Agreement:**

The Junior League of Arlington would like to offer all of our vendor participants free exposure on the Junior League of Arlington's Facebook page and Twitter account. We want to mention you, your Facebook page and website, and use photos of your wares on our Facebook page as a part of our social media advertising about the Cornhole Tournament. We will mention specifically which vendors and stores will be a part of our

event and include examples of what wonderful merchandise our visitors can expect to find!

If Junior League of Arlington should be prevented from hosting Cornhole Tournament for any cause beyond its control, or if it cannot permit the Vendor to occupy the booth space due to causes beyond its control, JLA has the right to cancel Cornhole Tournament and/or this Agreement with no further liability other than the refund of the Booth Rental fees less proportionate share of the cost of the event.

In any litigation brought to enforce the terms of this Agreement or on account of breach thereof, the prevailing party in such litigation shall be entitled to recover its collection costs, including reasonable attorney's fees in connection with such litigation, in addition to any other remedy provided by law.

- This Agreement is non-transferrable to another Vendor. The Junior League of Arlington has the option to cancel this Agreement upon non-fulfillment of this Agreement.
- Merchants who cancel after signing this Agreement and before September 30, 2016, will be refunded all but the deposit by JLA. After September 30, there will be no refunds on cancellations.

The Agreement shall be construed and governed by the laws of the State of Texas.

The Agreement shall not become effective until received and signed by an authorized representative of the Junior League of Arlington.
